Policy updates

This month, Representatives Pramila Jayapal (D-WA) and Nanette Barragán (D-CA), and Senator Cory Booker (D-NJ) introduced the HEAL for Immigrant Families Act in the US House and Senate. The HEAL Act would remove the barriers to federal health programs that disproportionately harm Black, Latinx, Asian, Pacific Islander, and other immigrants of color, including the five-year waiting period for Medicaid and the Children's Health Insurance Program, and the exclusion of undocumented immigrants from health insurance exchanges.
